Shivram Associates, have constructed Stilt + 4 floors residential building with 11 dwelling units and Departmental Store at Door No.47/2, Porur Main Road, Kundrathur, Chennai 600 069 in S.No.47/2, Kollacheri village, within the limit of Kundrathur Panchyat Union sanctioned in Planning Permission No. B/Spl.Bldg./163/2016, in Letter No.BC1/14219/2014 dated 11.8.2016, Planning Permit No.11001. The building was inspected and observed that the building has been completed as per approved plan and satisfies the Norms for issue of Completion Certificate approved by the Monitoring Committee.

2. Accordingly Completion Certificate is issued for the above construction in C.C.No.EC/Central-I/ 279 /2018 dated: 29-08-2018.

3. The Completion Certificate is issued in accordance with the provisions of the Town & Country Planning Act, 1971 and the Rules made there under. This Provision does not cover the Structural Stability aspect of the building. As far as the Structural Stability aspect of the building is concerned, it falls within the jurisdiction of the Local Body concerned as stated in the connected Building Rules under the respective Local Body Act, 1920, such as Madras City Municipal Corporation Act, 1919, Tamil Nadu District Municipality Act, Tamil Nadu Panchayat Act. The Completion Certificate issued under Development Regulations 4(5) does not cover the Structural Stability aspect. It is the sole responsibility of the Applicant/Developer/ Power Agent and the Structural Engineers/Licensed Surveyor/Architects, who has signed in the Plan to ensure the safety after construction and also for its continued Structural Stability of the buildings.
