This is to certify M/s.Sumanth & Co, has completed the construction of combined Basement floor, Block No:1 Consists of Stilt floor + 4 floors + 5th floor (part), Block No:2 Consists of Stilt floor + 5 floors totally two blocks of Residential building with 39 dwelling units availing with Premium FSI at Door No.6/13, Kesavaperumalpuram, North Avenue, Greenways Road, Mylapore, Chennai comprised in R.S.No.3957/2 (as per Document) & 3957/5 (as per patta) Block No.87 of Mylapore Village within the limits of Greater Chennai Corporation vide CMDA Planning Permission issued in the reference 2nd cited. It was inspected and observed that the building has been completed as per approved plan and satisfies the Norms for issue of Completion Certificate approved by the Monitoring Committee & TNCDBR 2019.

2. Accordingly Completion Certificate is issued for the above construction in C.C.No.EC/South-I/ 148 /2022 dated 25.05.2022.

3. In accordance with the Provisions of the Town & Country Planning Act, 1971 and the Rules made there under. This Provision does not cover the Structural Stability aspect of the building. As far as the Structural Stability aspect of the building is concerned, it falls within the jurisdiction of the Local Body concerned as stated in the connected Building Rules under the respective Local Body Act, 1920, such as Madras City Municipal Corporation Act, 1919, Tamil Nadu District Municipality Act, Tamil Nadu Panchayat Act. The Completion Certificate issued under Development Regulations 4(5) does not cover the Structural Stability aspect. It is the sole responsibility of the Applicant/Developer/ Power Agent and the Structural Engineers/ Licensed Surveyor/Architects, who has signed in the Plan to ensure the safety after construction and also for its continued Structural Stability of the buildings.

4. Further, the Completion Certificate issued is subject to outcome of the Hon'ble High Court order in the reference 1st cited (Also indicated in the Planning Permission approval letter in serial No. 12th reference)
