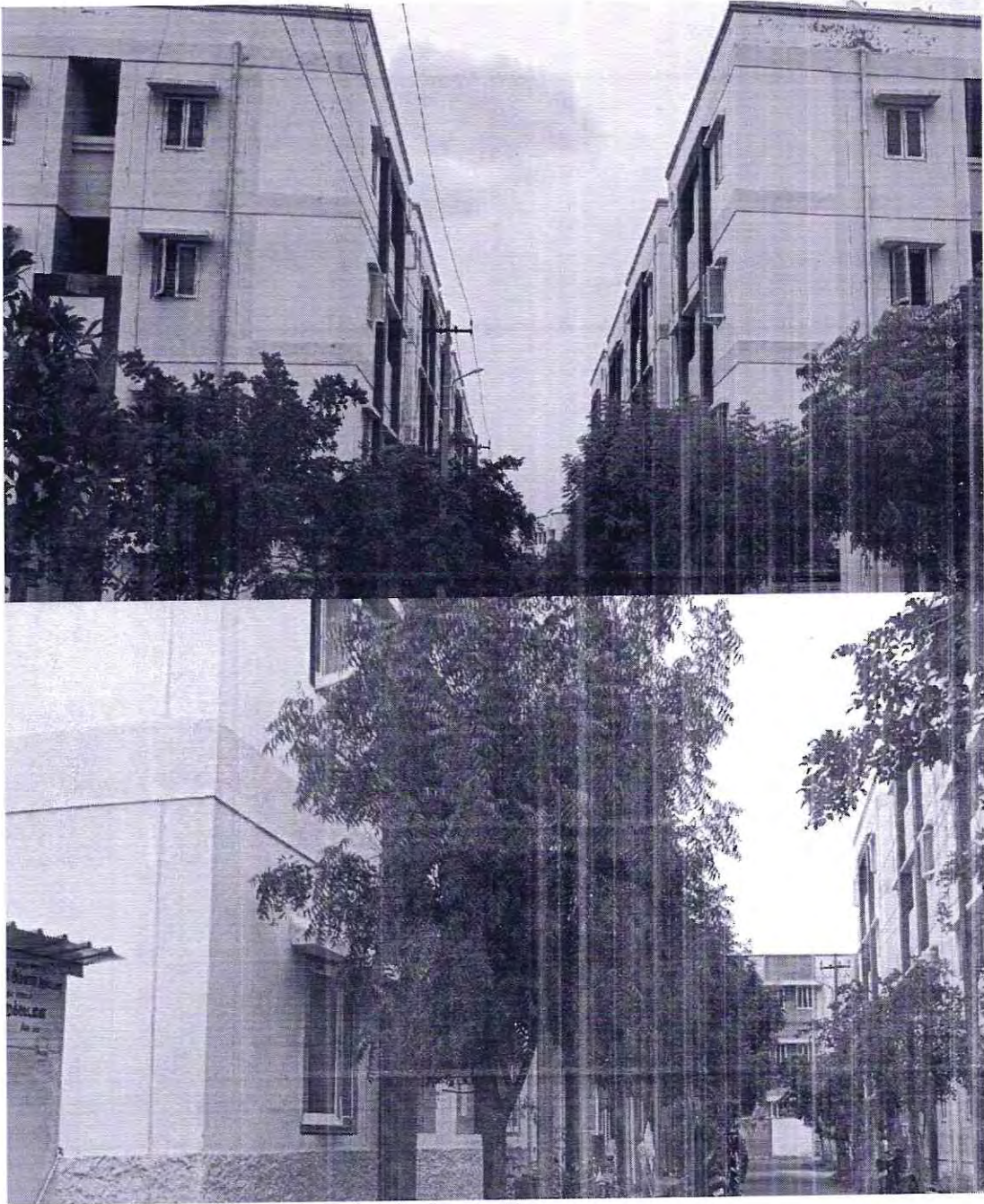

Roc.No.2713/2018/TLPA dated. 26.08.2019 and consequently Building Permission BA No. 032/BPA/2020/00075-A dated 07.02.2020 was issued by the Commissioner, Tiruppur Corporation. It was inspected and observed that the building has been completed as per the approved plan and satisfies the norms for issue of Completion Certificate.

2) Accordingly, Completion Certificate is issued for the above construction vide C.C.No.05/2022 dated:09.12.2022 with the condition that as per the TNCD&BR-2019 Rule 41(2)(2) the OSR site so reserved shall be exclusive of the set back spaces and spacing between blocks prescribed in these rules, and shall be free from any construction or structure.

3) The Completion Certificate is issued in accordance with the provisions of Tamil Nadu Town & Country Planning Act, 1971 and the rules No.20 of Tamil Nadu Combined Development and Building Rules 2019. As far as the Structural Stability/Adequacy aspect of the building is concerned, it is the sole responsibility of the Applicant / Developer / Power Agent and Structural Engineer / Licensed Surveyor / Architect and construction Engineer who had been involved in the construction works of the said building. Hence this Completion Certificate does not endorse the structural adequacy of the building.
