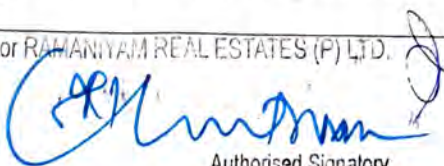

The Planning Permission Application for the Proposed construction of High Rise Building (HRB) Residential purpose consisting of Extended Basement floor + Stilt floor + 9 floors with 72 dwelling units availing with **Premium FSI** at TNHB Block No. M7, M8, M9 & M10, Ashok Colony, Anna Main Road, K. K. Nagar, Chennai 600078 comprised in S. No. 408 pt & 412pt (As per Document) and T.S. No. 253/2, Block No. 112 & T.S.No.183/3, Block No. 113 (As per Patta), Kodambakkam village has been examined and Planning Permission is issued based on the Government approval accorded in the reference 5th cited subject to the usual conditions put forth by CMDA in reference 6th cited, including compliance of conditions imposed by the Government agencies in the reference 7th, 8th, 10th & 11th cited and subject to the conditions.

2. The applicant has remitted the DC & other charges in letter dated 17.11.2021 vide receipt No. B0020319, dated 17.11.2021:

3. The applicant has furnished Bank Guarantee of Rs. 24,00,000/- (Rupees Twenty Four Lakh only) towards security deposit for building vide Bank Guarantee No. 11650100018920 dated 12.04.2021, valid up to dated 11.04.2026 issued by Axis Bank limited, Anna salai branch, Chennai 600 002.

4. Applicant has utilized DRC No.033/2015, dated 17.11.2015 and 057/2017, dated 07.09.2017 towards the remittance of Premium FSI Charges of Rs.3,00,70,000/- (Rs.2,88,12,687/- + Rs.12,57,313/-)(Rupees Three crore seventy lakh only).

5. Applicant has remitted Rs.18,47,517/- (Rupees Eighteen Lakh, Forty Seven Thousand, Five hundred and Seventeen only) towards Interest on Premium FSI charges vide cash receipt No.B0020428, dated 01.12.2021.


6. Applicant has also furnished an undertaking in the reference 14th cited to abide by the terms and conditions put forth in the NOC's issued by AAI , IAF, DF&RS & Police (Traffic) and the conditions imposed by CMDA in the reference 9th cited.


7. The Promoter has too submit the necessary application directly to CMWSSB and only after due sanction he can commence the internal sewer works.

In respect of water supply, it may be possible for CMWSSB to extend water supply for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 (ten) lpcd. In respect of requirement of water for other uses, the applicant has to ensure that he can make alternate arrangements. In this case also, the applicant should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks are hermitically sealed with properly protected vents to avoid mosquito menace. Non provision of rain water harvest structures shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of TNCD&BR and enforcement action will be taken against such development.

8. The Planning Permission for buildings is issued in accordance with the provisions of the Town & Country Planning Act, 1971 and the rules made there under. All other statutory clearance as applicable to this project shall be obtained by the project proponent from the competent Authority. The Town & Country Planning Act provision does not cover the Structural Stability aspect of the building including the safety during the construction. However, these aspects are covered under the provisions of the Local Bodies Act.

As far as, the Structural Stability aspect of the building is concerned, it falls within the jurisdiction of the Local Body concerned as stated in the Building Rules under the respective Local Body Act 1920, such as Madras City Municipal Corporation Act 1919, Tamil Nadu District Municipality Act, Tamil Nadu Panchayat Act. The Planning Permission issued under the provision of Tamil Nadu Town & Country Planning Act 1971, does not cover the Structural Stability aspect. However, it is the sole responsibility of the applicant / developer /Power Agent and the Structural Engineers / License Surveyor / Architects who has signed in the plan to ensure the safety during construction and after construction and also for the continued structural stability of the buildings. In this regard, applicant along with the Architect and Structural Engineer and Construction Engineer has furnished necessary undertakings for Structural Design Sufficiency as well as for supervision in the prescribed formats.

However, the applicant has furnished the Structural design report & Drawings vetted by PWD as in the reference 9th cited.

9. Issuance of Planning Permission by CMDA under the statutory provisions does not confirm any ownership or title over the property, in favour of the applicant. Before issuing Planning Permission for any development, CMDA in this regard, checks only the aspect of applicant's right over the site under reference to make the development thereon based on the copies of the documents (such as Sale Deed, Patta, Lease Deed, Gift Deed etc., and GPA) furnished by the applicant along with his /her application to prove the same. Thus, CMDA primarily considers only the aspect whether the applicant prima facie has a right to carry out development on the site under reference.

Any person who acquires interest in the property shall ensure independently about the ownership and the applicant's right before acquiring the same. Further, if any individual claim right (or) title over the property he / she / they shall have to prove it before the appropriate / competent Court to decide on the ownership or get the matter settled in the Court of Law and CMDA is not the competent authority to decide on this matter. All other statutory clearance as applicable to this project shall be obtained by the project proponent from the competent authority.

10. The Planning Permission holder shall be responsible to ensure that the Building / Structure in the adjoining site are not weakened / Damaged during the construction of Basement floor and also to provide lighting & ventilation and protection from the fire to the satisfaction of Director of Fire and Rescue Service.

11. Applicant has to erect temporary lightning arrester during the entire construction phase of the project.

12. All other statutory clearance as applicable to this project shall be obtained by the project proponent from the competent Authority.

13. The Executive Authority of Local Body before issuing Building Permit for the construction of new building shall ensure if it has a provision in the building design itself for an insulated pipeline from the rooftop in the building to various distribution points where hot water is required. The new building shall have provision for continuous water supply to the solar water heating system. The new building shall also have open space on the roof top to receive direct sun light. The load bearing capacity of the roof shall atleast be 50 Kilogram per Sq.m. All new buildings shall have solar assisted water hearing system installed before they are utilized for business or other activity.

The capacity of solar water assisted water heating system to be installed shall be decided in consultation with the Executive Authority. The recommended minimum capacity shall not be less than 25 Litres per person per day for each bath room and kitchen subject to the condition that maximum of 50 percent of the total roof area is provided with the system as per norms to be fixed by the Tamil Nadu Energy Development Agency from time to time.

14. The applicant shall reserve 1/3rd open Terrace Area for erection of Solar Photo Voltaic Panel and the same has to be ensured before issue of Completion Certificate

15.As per G.O.(Ms) No.112, H&UD Department dt.22.06.2017, the promoter has to advertise, market, book, sell or offer for sale, or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part of it, only after registering the Real Estate Project with the Real Estate Regulatory Authority.

16.The partial refund of security deposit will not be considered for issuance of partial Completion certificate.

17.This Planning Permission is issued under New Rule TNCD&BR 2019 subject to final outcome of the W.P.(MD) No. 8948 of 2019 and WMP (MD) Nos. 6912 & 6913 of 2019.

18. CCTV Camera to be installed at regular interval of 50.00 m along the road which is abutting the site boundaries before issue of Completion Certificate. In this regard the applicant has furnished an undertaking.

19.The applicant is requested to intimate the Enforcement Cell, CMDA at all the stages of construction of building viz., namely (i) Commencement of construction, (ii) Plinth level and (iii) Last Storey and apply for Completion Certificate along with order of continuance accorded for different stages by CMDA.

20.Two sets plan for the proposed development is approved and numbered as C/PP/MSB/64(A to D)/2021, dated 03.01.2022 in Planning Permit No.14518 are sent herewith. The Planning Permit is valid for the period from 03.01.2022 to 02.01.2027.

21. This approval is not final. The applicant has to approach the Commissioner, Greater Chennai Corporation for issue of Building Permit under the Local Body Act.

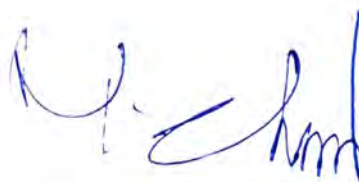

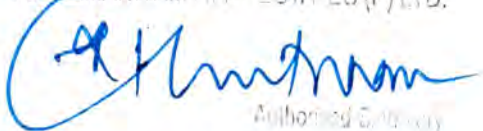
