Miscellaneous Application has been filed under Section 44(2) of RERA Act, to condone the delay of 221 days in filing the appeal.

Appeal has been filed under Section 44 of the Real Estate (Regulation and Development) Act, 2016, to set aside the order dated 07.12.2021 in CCP No.154 of 2020 passed by the Learned Adjudicating Officer, TNRERA.

ORDER

When the matter is taken up for hearing, Mr.O.L.V.Ganesan, learned counsel for the appellant and Mr.Amar Panwar, learned counsel for the respondents submitted that the parties had settled the matter out of Court and also entered into a Joint Compromise Memo dated 02.11.2023. The learned counsel on either side also produced a copy of the Joint Compromise Memo and the same is taken on record.

2. In the Joint Compromise Memo, the appellant has stated that they have deposited a total sum of Rs.14,66,124/- under Section 43(5) of the Act before this Tribunal. Further, the parties have agreed that out of the total sum of Rs.14,66,124/-, a sum of Rs.8,50,000/- should be paid to the respondents and the remaining amount of Rs.6,16,124/- should be refunded to the appellant.

3. The appellant and the respondents are entitled to receive their proportionate accrued interest on the amount deposited by the appellant under Section 43 (5) of the Act.

4. In view of the Joint Compromise Memo dated 02.11.2023, the application in M.A.No.172 of 2023 stands disposed of in terms of the Joint Compromise Memo and the terms of the compromise shall

form part of the order in this application. Consequently, the Appeal in Appeal (SR).No.13 of 2023 stands closed.

1. The Parties submit this memo in MA no.172 of 2023 in A.SR.No.13 of 2023.
2. The Appellant submits that subject case has been settled out of court as per the discussions between the parties. The Appellant has pre-deposited a total sum of Rs.14,66,124/- (Rupees Fourteen lakh sixty six thousand one hundred and twenty only) as per Sec 43(5) of RERAtowards the Appeal.
3. It is submitted that on mutual consent between the parties, out of the said deposited sum, it is agreed that the amount deposited shall be paid out as set out hereunder:-
 - a) A sum of Rs.8,50,000/- (Rupees EightLakh Fifty Thousand only) shall be ordered to be withdrawn and paid to the Respondent as full and final settlement of all claims
 - b) The remaining sum of Rs.6,16,124/- (Rupees SixLakh SixteenThousand Hundred and Twenty Four only) shall be ordered to be withdrawn and released to the Appellant
 - c) On the aforesaid terms of full and final settlement, the Parties settle all issues, claims and disputes among them.

7. The parties humbly pray that the Honourable Tribunal may kindly accept this Joint Compromise Memo on record and dispose the Appeal in terms of the Joint Compromise and pass necessary orders as deem fit in the circumstances and thus render justice.
