The Miscellaneous Application has been filed seeking to grant leave for the appellants herein to file appeal under Section 43(5) of RERA against the order dated 10.02.2022 and 22.02.2022 in E.P.Nos.49 to 70 of 2021 filed against the C.C.P.Nos.108, 273, 274, 275, 276, 277, 278, 292, 320, 321, 322, 323, 324, 325, 326, 337, 338, 339, 340 of 2019, 4, 6, 13 of 2020.

The Appeal has been filed under Section 44 of the Real Estate (Regulation and Development) Act, 2016 to set aside the findings and order dated 10.02.2022 and 22.02.2022 passed by the learned Adjudicating Officer, TNRERA, Chennai in E.P.Nos. 49 to 70 of 2021 in C.C.P.Nos.108, 273, 274, 275, 276, 277, 278, 292, 320, 321, 322, 323, 324, 325, 326, 337, 338, 339, 340 of 2019, 4, 6, 13 of 2020 insofar as it relates to the lands comprised in S.Nos.385/1A, 1B, 2A, 2B, 2C and S.Nos.123/2A, 2B1, 2B2, 5A, 5B1A, 5B1B, 5B1C, 5B2 and 5C of Ninnakarai Village, Chengalpattu Taluk and District, totally measuring an extent of 2.66 acres.

ORDER

The 3rd party applicants have filed the above application seeking leave to file the appeal as against the order passed in E.P.Nos.49 to 70 of 2021 on the file of the learned Adjudicating Officer, TNRERA, Chennai.

2. By order dated 10.02.2022, the learned Adjudicating Officer passed an order for recovery under Section 40(1) of the RERA Act for non-compliance of the orders in C.C.P.No.108 of 2019 dated 29.11.2019 and C.C.P.Nos.273 to 278, 292, 320 to 326, 337 to 340 of 2019, 4, 6, 13 of 2020 dated 25.06.2021. The orders were passed as against the 23rd respondent in this application, viz., M/s.RVS Developers Pvt. Ltd., rep. by Its Director S.Senthil Azhagan. The applicants claim that they are the owners of the land and that they entered into a Sale Agreement with the 23rd respondent and also executed a general Power of Attorney in their favour. Pursuant to the orders passed in C.C.P.Nos.108 of 2019, 273 to 278, 292, 320 to 326, 337 to 340 of 2019, 4, 6, 13 of 2020, the complainants filed Execution Petitions in E.P.Nos.49 to 70 of 2021.

3. It is brought to the notice of this Tribunal that the orders passed in the Compensation Claim Petitions have become final and that no appeal has been preferred by the 23rd respondent. It is also not in dispute that the 23rd respondent entered into Sale Agreements with the respondents 1 to 22. When the orders passed in the C.C.Ps have become final, the complainants preferred Execution Petitions against the 23rd respondents, which resulted in the order dated 10.02.2022 by the learned

Adjudicating Officer for issuance of recovery warrant under Section 40(1) of the RERA Act.

4. It is also brought to the notice of this Tribunal that the applicants have also filed three other un-numbered Applications before the learned Adjudicating Officer in E.A.(SR).Nos.76, 77 & 78 of 2023 in E.P.Nos.49 to 70 of 2021 to set aside the order passed in the Execution Petitions, to stay the order passed in the Execution Petitions and to grant leave to contest the Execution Petitions. The un-numbered Applications were dismissed by the learned Adjudicating Officer as not maintainable. Challenging the same, instead of filing three separate appeals, the applicants have filed only one appeal in Appeal (SR) No.76 of 2024. When the learned Adjudicating Officer had dismissed the applications filed by the present applicants as not maintainable and declined to permit them to contest the Execution Petitions, we do not find any reason to grant leave to the applicants to challenge the common order passed in E.P.Nos.49 to 70 of 2021.

5. The learned counsel appearing for the applicants submitted that there is a dispute between the applicants and the 23rd respondent and therefore, leave should be granted to them to file the appeal as against the order passed in the Execution Petitions.

6. Since the applicants are not parties to the Sale Agreements entered into between the respondents 1 to 22 and the 23rd respondent, the dispute between the applicants and the 23rd respondent shall not come within the purview of the RERA Act. The dispute between the applicants and the 23rd respondent can be resolved only before a

competent Civil Court. In such view of the matter, we do not find any merits in the present application for granting leave to file appeal. The application is devoid of merits and the same is dismissed. Consequently, the appeal in Appeal (SR).No.70 of 2024 is rejected.
