**ORDER FOR RECOVERY UNDER SECTION 40(1) OF THE RERA ACT READ
WITH RULE 26 OF TNRERA RULES FOR NON-COMPLIANCE
OF THE ORDER IN THE ABOVE CCP DATED 20/06/2022**

1. The above complainants filed the petition for execution stating that the respondents have not complied with the order passed in the above CCP filed by them.
2. The respondent have not obtained any stay in any appeal preferred by the respondent before the Appellate Tribunal nor has he paid the amount due to the complainants in compliance of the order of this Forum.
3. In the above CCP, the respondents are directed to pay the complainants, the amount of Rs.28,39,444/- as on 24/07/2023 with interest @ 9.30% p.a, for the paid sum of Rs.21,00,000/- from 24/07/2023 till realization and litigation expenses of Rs.25,000 as ordered in CCP No. 271 of 2021 dated 20/06/2022. (i.e. Rs.21,00,000/- with interest at the rate of 9.30% p.a from the date of

respective payment till 24/07/2023 and litigation expenses = Rs.28,39,444/-)
(Rs.21,00,000/- + Rs.7,14,444/- + Rs.25,000 = Rs.28,39,444/-)

4. Since, the amount due to the complainants under the order is due and liable to be recovered, it is just and necessary to issue warrant under Section 40(1) of the RERA Act read with Rule 26 of the TNRERA Rules. The EP disposed of accordingly.

In the result, it is ordered as follows:

Issue recovery warrant under section 40(1) of the RERA Act read with Rule 26 of TNRERA Rules to the District Collector, Chennai District, to collect the same for the satisfaction of the claim under the orders passed in favor of the above complainants.
